**MEMORANDUM OF UNDERSTANDING
(MOU)
FOR
ACADEMIC EXCHANGE AND COOPERATION
BETWEEN
UNIVERSITY OF PETRA (UOP), AMMAN JORDAN
AND
FRIEDRICH SCHILLER UNIVERSITY JENA
(JENA CENTER FOR RECONCILIATION STUDIES),
GERMANY**



In order to extend the effective and mutually beneficial cooperation and develop academic and cultural exchange in education, research and other areas, the University of Petra, Amman, Jordan and the Friedrich Schiller University Jena, Germany hereby agree to cooperate toward the internationalization of higher education.

The areas of cooperation will include any program offered at either university which is felt to promote the above-mentioned goals. However, any specific program shall be subject to mutual consent, availability of funds and the approval of both universities. Such programs may include:

- a) exchange of faculty members
- b) exchange of students
- c) exchange of publications
- d) joint research projects
- e) joint conferences
- f) joint teaching projects
- g) joint cultural programs

The terms of such mutual assistance and cooperation shall be discussed and agreed upon in writing by the responsible authority of each university prior to the initiation of any particular program or activity.

This agreement shall take effect upon approval by both parties and shall remain in effect for an initial period of five (5) years. The Memorandum may be amended or renewed only upon mutual written consent. However, either university may terminate the agreement in writing at least ten months prior to the beginning of an academic term/year.
