MEMORANDUM OF UNDERSTANDING (MoU)

Whereas University of Petra, an Accredited Jordanian Higher Education Institution, (hereinafter referred to as UOP) and the Luminus Education, an Accredited Jordanian Community College (hereinafter referred to as Luminus) are linked by common academic and cultural interests; and

Whereas these two institutions wish to enable cooperation in all academic and educational areas of mutual interest;

THE PARTIES, UOP and LUMINUS HAVE REACHED AN UNDERSTANDING as follows:

ARTICLE I AREAS OF COOPERATION

The purposes of this MoU include, but are not limited to, the following:

1. The development of collaborative teaching and collaborative projects.
2. The organization of joint academic and teaching activities, such as courses, conferences, seminars, symposia or lectures.
3. The exchange of research and teaching personnel.
4. Considering giving the preference in appointing Luminus graduates at the UOP in required technical facilities.
5. Offering Luminus graduates the facility of continuing studies at the UOP.

Cooperative agreement under this MoU may include any of the academic disciplines represented at either of the two institutions.

ARTICLE II LETTER OF AGREEMENTS AND IMPLEMENTATION

In order to carry out and fulfill the aims of this MoU, UOP and Luminus will assign an appropriate person at each of their campuses to coordinate the development and conduct of joint activities. Through these contact persons, either institution may initiate proposals for activities under this MoU. Specific details of any activity will be set forth in a Letter of Agreement, which, upon signing by appropriate authorities at both Institutions will become an integral part of this MoU. Letters of Agreement will include such items as:

1. Elaboration of the responsibilities of each institution for the agreed-upon activity.
2. Schedules for the specific activities.
3. Budgets and sources of financing of each activity.
4. Any other items necessary for the smooth and efficient conduct of the activity.

The contact persons will additionally be responsible for the evaluation of activities under this MoU according to the practices of their respective institutions. Letters of Agreement will be approved at each institution according to the normal procedures governing the types of activities proposed therein.

ARTICLE III FINANCIAL ARRANGEMENTS

Except as maybe stipulated in any specific cooperation agreement, each institution shall be responsible for expenses incurred by its employees under this MoU.

ARTICLE IV ENTRY INTO EFFECT AND DURATION

Upon approval by each institution, this MoU shall remain in effect for a period of **five (5)** years unless terminated earlier by either institution. Such termination by one institution shall be effected by giving the other institution at least ninety (90) days advance written notice of its intention to terminate. Termination shall be without penalty. If this MoU is terminated, neither Luminus nor OUP shall be liable to the other for any monetary or other losses which may result.
